These consultation questions seek views on the detail of the legislation that will: introduce same sex marriage; allow civil partnerships to be registered through religious or belief ceremonies; and make other changes to marriage law. Further information on the detail of the legislation is available below each question (see 'more information') and in the consultation paper.

Impact assessments

Question 1 (Paragraphs 1.14 to 1.17 and Annexes J and K).

Your comments

I have no comments to make about the impact assessments other than to observe that the financial impact on my congregation of a move to allow same-sex marriage would be positive. Though there might be some small administrative expenses I would expect to conduct more weddings and my congregation would thereby expect to receive increased wedding fees.

General changes to marriage law

Question 2 (Paragraphs 2.02 to 2.04)

Do you have any comments on allowing opposite sex and same sex civil marriage ceremonies to take place anywhere agreed between the registrar and the couple, other than religious premises?

I think this is a welcome development.

Question 3 (Paragraphs 2.05 to 2.10)

Do you have any comments on establishing belief ceremonies as a third type of ceremony, alongside religious and civil, for getting married in Scotland?

The current proposals would introduce an obvious direct discrimination against religious people. If a group of people whose religious views are non-theistic can join together to form a society or organisation which would allow them to conduct weddings it seems quite wrong for the state to refuse to allow similar groups of theistic believers to join together to be able to perform marriages.

In other words, if humanist groups are allowed to conduct weddings, religious groups other than the churches should also be allowed to conduct weddings.

Not to allow this would be discriminatory on the basis of religion and subject to a human rights challenge.

Question 4 (Paragraphs 2.11 to 2.14)

Do you have any comments on amending section 8 of the Marriage (Scotland) Act 1977 so that Church of Scotland deacons are authorised automatically to solemnise opposite sex marriage?

Question 5 (Paragraphs 2.15 to 2.21)

Do you have any comments on establishing tests that a religious or belief body must meet before its celebrants can be authorised to solemnise marriage or register civil partnership?

Someone who wishes to celebrate a marriage should be someone who has not broken marriage laws, immigration laws or been found guilty of fraud. There is a case for ensuring that a marriage celebrant has no convictions which would lead someone to feel concern at their contact with vulnerable people.

It would be appropriate for the same safeguarding regulations to apply to all celebrants similar to those which currently are used by the churches.

I see no reason why someone should not charge a fee for providing a service.

Question 6 (Paragraphs 2.28 to 2.31)

Do you have any comments on abolishing the concept of marriage by cohabitation with habit and repute where a couple erroneously believed themselves to be married but it transpired after one of them died that the marriage was not valid?

This would be a positive development. It needs to be possible to determine as clearly as possible in law whether someone is or is not married and it is not unreasonable to expect a couple to establish the fact of their marriage by a positive, intentional legal process.

Same sex marriage

Question 7 (Paragraphs 3.03 to 3.07 and Annex A)

Do you have any comments on the proposals for authorising religious and belief celebrants who wish to solemnise same sex marriage?

I believe that if someone is authorised to conduct a straight couple's marriage then they should automatically be authorised to conduct marriages of same-sex couples. The law should apply equally to people and what has been proposed is not equality. For these reasons, I do not support the current proposals for determining who can and who can not conduct the marriage of a same-sex couple.

If churches wish to limit the ability of a celebrant to conduct a marriage then they should continue to be able to do that through their own internal disciplinary procedure.

I look forward to being able to celebrate marriages for same-sex couples one day in my congregation (St Mary's Cathedral, Glasgow). I note with interest that once the state licenses marriages for same-sex couples, my own denomination (The Scottish Episcopal Church) will automatically have an authorised liturgy for blessing such couples – the service of Benediction, which is explicitly authorised in Canon Law for use with couples whose marriage is legal but which has not been performed according to the rites of the church.

Question 8 (Paragraphs 3.08 to 3.10)

Do you have any comments on opt-outs for civil registrars who do not wish to solemnise same sex marriage?

Civil registrars should not be able to opt out of performing marriage services for any couple who intend to contract a legal marriage. For that reason, I support these proposals.

The government needs to balance a right to free speech with someone's right not to be subjected to harassment and abuse. There is no absolute right to free speech in this country and the government should not pander to any demands to make it appear that there is.

I'm extremely concerned at the current proposals which could reintroduce an education system where children might find themselves unable to access information and services relating to being gay.

The education system should ensure that all pupils in all schools are educated in a way that ensures that children have ready and easy access to information about LGBT issues. Any attempt to limit that should be vigorously resisted.

There is no place for discrimination in the education system. No school should be tolerated in Scotland where discriminatory attitudes to anyone on the grounds of race, sexuality, gender identity etc are promoted or tolerated. It is unacceptable that public money should be used to provide education where discriminatory attitudes are promoted.

The only changes needed to the education system in this area are increased vigilance in the area of homophobic bullying.

Civil partnership
